

SUMMARY ANNUAL REPORT
FOR THE
BUFFALO LABORERS' SECURITY FUND

This is a summary of the Annual Report for the Buffalo Laborers' Security Fund (the Fund), (Employer Identification No. 16-1605100 Plan No. 001) for the period July 1, 2015 to June 30, 2016.

The annual report has been filed with the Internal Revenue Service, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$899,880. These expenses include \$145,070 in administrative expenses and \$754,810 in benefits paid to participants and beneficiaries. A total of 1,453 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$19,334,188 as of June 30, 2016 compared to \$18,176,390 as of July 1, 2015. During the plan year the plan experienced an increase in its net assets of \$1,157,798. The plan had total income of \$2,057,678. This income included employer contributions of \$2,253,691, income from realized gains on sale of assets of \$274, other income of \$23,156 net investment gain (loss) from common collective trusts of (\$4,843) interest from investments of \$76,015 and interest from interest bearing cash of \$413, dividends from registered investment company shares of \$195,778 and net investment gain (loss) from registered investment companies of (\$486,806).
